Recipients will be selected by March 15. The scholarship award will expire 15 months from the date of the award to allow the applicant to split distribution of funds over two (2) membership years.

# Scholarship for New Round Dance Leaders

## Application Information Sheet

### **Applicant Eligibility and Requirements**

The guidelines of the Scholarship for New Round Dance Leaders control the awarding of this scholarship. Briefly, the guidelines outlining the applicant's eligibility and requirements are:

- Shall not be a current or former member of ROUNDALAB (RAL).
- Can only receive a Scholarship for New Round Dance Leaders once in the lifetime.
- Must be working towards becoming a round dance leader.
- Must be working with their RAL Mentor at least three (3) months immediately preceding their application for a Scholarship for New Round Dance Leaders.
- Must demonstrate their intent in pursuing a long-term commitment to becoming a round dance leader to their RAL Mentor.
- Must complete and submit an application to become a RAL member along with this application form.
- Must obtain their RAL Mentor's sponsorship of both applications.

### **Election for Distribution of Funds**

The scholarship award will be given a value that represents the current year membership, licensing and insurance fees, and the cost of the initial RAL RTV Library subscription. Should your Scholarship for New Round Dance Leaders application be awarded, you have the option of electing a single or split (two-year) distribution of funds. The total value of the scholarship award will not be increased if you elect to have the award split over two years.

- **Single Distribution**  
The total value of your award will be applied to 100% of your current membership, licensing and insurance fees, and the cost of your initial RAL RTV Library subscription.
- **Split (Two-Year) Distribution**  
The total value of your award will be split 67%-33% towards your first- and second-year membership, licensing and insurance fees, and the cost of your initial and renewal RAL RTV Library subscription as follows:
  - **First Year Distribution (67%):**  
First-year distribution of funds will first be applied to cover the full cost of your initial RTV Library subscription with the balance of your first-year distribution applied towards your membership, licensing and insurance fees. You will be financially responsible for the remaining balance of your membership, licensing and insurance fees.
  - **Second-Year Distribution (33%):**  
Second-year distribution of funds will first be applied to two-thirds ( $\frac{2}{3}$ ) the cost of the then-current RTV Library subscription with the balance of your second-year distribution applied towards your then-current membership, licensing and insurance fees. You will be financially responsible for the remaining balance of your membership, licensing and insurance fees.

Split distribution of award funds provide an offset for two years of membership, licensing and insurance fees, and the cost of the RTV Library.

***RAL Operational Procedures (OP) 7.01.03 - Scholarship for New Round Dance Leaders controls this scholarship program. It is advisable that you review OP 7.01.03 with your RAL Mentor before submitting your application.***
